OWLUA Umpire Agreement: By submitting this Umpire Registration and Agreement Form, I acknowledge and agree that I release and hold OWLUA harmless from any and all claims arising out of the activities connected with OWLUA and associated lacrosse activities. (Registered members of USL receive USL general liability and accident insurance coverage while participating in covered activities.) I acknowledge, agree, and represent that I am a member of USL. I understand and agree that I am eligible to officiate at the appropriate level of competition indicated by my experience and rating, and must exercise my own independent skill and initiative in officiating lacrosse games. I understand I may decline or accept games assigned to me based on the schedule I provided, and fully understand there are no assurances of the number, type, or location of game assignments. I understand and agree that I have a location other than assigned playing fields where I can electronically access and complete a Game Report following every game I officiate. I accept umpire compensation and reimbursement rates for 2016. I acknowledge my obligation for payment of dues and fees for OWLUA membership. I understand my registration and association with OWLUA does not create an employment contract or an employment relationship with OWLUA or any lacrosse program. I will act and be considered an independent contractor while serving as an OWLUA umpire in accordance with Oregon statutes, though OWLUA may be required by law to deduct employment taxes from umpire compensation. As an umpire, I will conduct myself in a professional manner that demonstrates total impartiality, courtesy, and fairness to all parties. I certify that all information provided by me in this form is true, accurate, and complete.
